East Metro Place provides 20 units of transitional housing for homeless families with children and is located near Century College in White Bear Lake. All units receive rental assistance to make the housing affordable to very low income families. Adults receive a wide range of services, including case management, Dialectical Behavior Therapy (DBT) skills training, budgeting, tenant training, referral to mental/chemical health services, and education. East Metro Place also hosts the Learning & Enrichment Program, an after-school tutoring program for students in grades K-8. East Metro Place houses approximately 120 adults and children annually.

4b (Code:) (Expenses \$ **310,152** including grants of\$) (Revenue \$)

East Metro Place II provides 14 units of permanent supportive housing, co-located at the White Bear Lake campus. Seven units serve families with histories of long-term homelessness and seven units serve families with disabilities. All 14 families also receive rental assistance, after-school tutoring and other support services as described above. East Metro Place II houses about 75 adults and children annually.

Home Again provides 10-12 units of scattered-site "rapid re-housing" in Washington County. Families receive in-house services and a monthly rental subsidy for 6-12 months while they stabilize and work to increase their income. The Home Again program serves about 70 adults and children each year.

Homesafe provides 12-15 units of scattered site transitional housing in Ramsey and Washington counties. Families receive monthly rental assistance, based on unit size and time in program, as well as supportive services for 12 to 18 months while they work to regain stability and increase their income. The HomeSafe program serves about 80 adults and children annually.

The HomeFront program opened in August 2016, offering 10 units of supportive housing for formerly homeless veterans and their families. All units receive rental assistance to make the housing very affordable for lower income families. Onsite services are provided to help veterans and their family members achieve housing stability and work toward life goals such as advancing their education, securing gainful employment and improving their health. HomeFront serves about 30 adults and children annually.
