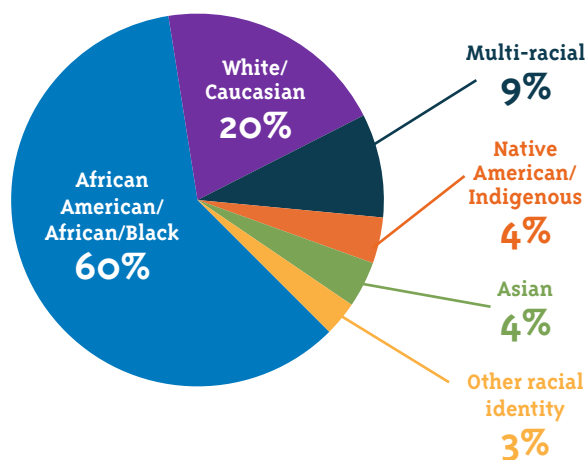
Who We Serve

Age



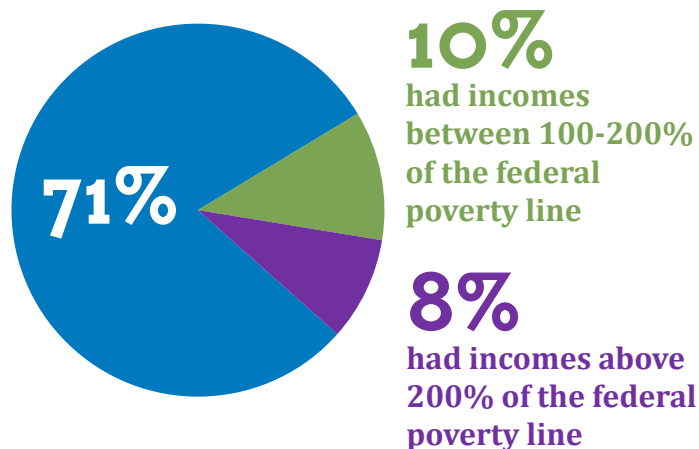
Demographics

Solid Ground's Foundations for a Stronger Future Capital Campaign is a three-year, \$6.6 Million effort to expand safe, affordable housing for families experiencing homelessness.

- Pillar 1 renovated East Metro Place with secure entry, updated program areas, and expanded offices.
- Pillar 2 is creating more than 100 new homes with supportive services through community partnerships.
- Pillar 3 will address long-term needs at East Metro Place, including apartment updates, building systems, and outdoor spaces.

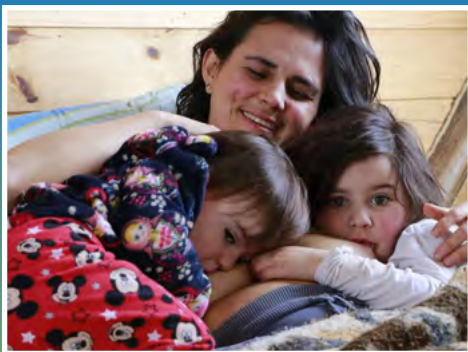
